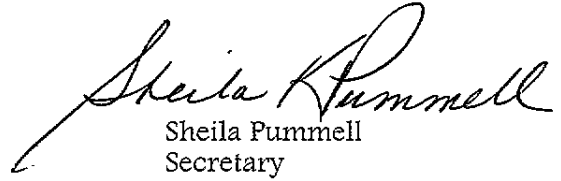
This corporation is changing the corporate name to be SOUTHERN ELEVATOR DRILLING, INC. effective May 31, 2002.
