ARTICLES OF INCORPORATION
OF
A & G DURABLE MEDICAL EQUIPMENT, INC

ARTICLE I - NAME

The name of this Corporation is A & G DURABLE MEDICAL EQUIPMENT, INC.

ARTICLE II - DURATION

The Corporation shall have perpetual existence commencing on the dates these Articles of Incorporation are filed with the Florida Secretary of State's Office.

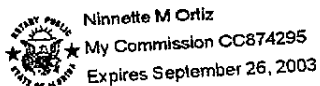
