

OF

**ARTICLE I - NAME AND BUSINESS ADDRESS**

The name of this Corporation is Pure Competition, Inc. Its principal office address and business mailing address is 5350 SW 130 Terrace, Miramar, Florida 33027, Attn: Steve Albert Russell.

**ARTICLE II - DURATION**

The Corporation shall have a perpetual existence.

**ARTICLE III - PURPOSE**

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

**ARTICLE IV - CAPITAL STOCK**




