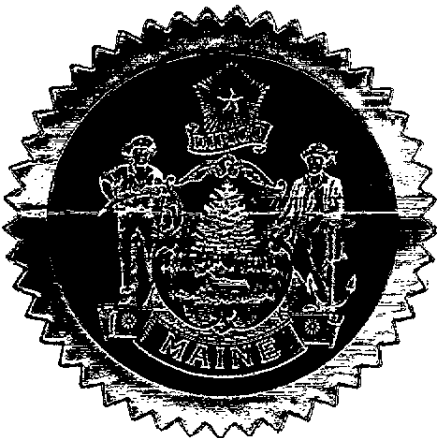
## *Department of the Secretary of State*
