ARTICLE XI

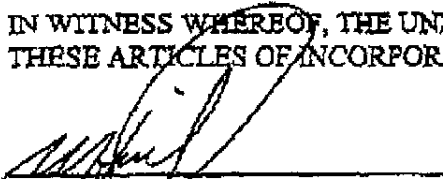
AMENDMENT
