ADMISSION OF NEW MEMBERS

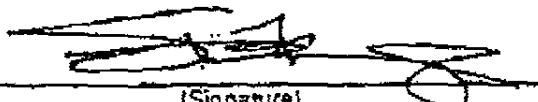
Unless otherwise herein specified, no new Members shall be admitted to the Limited Liability
