THIRD ARTICLES OF AMENDMENT OF ANDOVER POINT HOMEOWNERS' ASSOCIATION, INC.

1. The following provisions of the Articles of Incorporation of ANDOVER POINT HOMEOWNERS' ASSOCIATION, INC., a Florida corporation, filed in Tallahassee, Florida on September 17, 2001, Document number NO10000006597 as previously amended by Articles of Amendment filed on January 29, 2002 and Second Articles of Amendment filed on August 12, 2002 be and are hereby amended as follows:

That portion of Article VII, Voting Rights, which was previously modified to reads as follows:

- Class B: The Class B member(s) shall be the Declarant/Developer (as defined in the Declaration) and shall be entitled to three (3) votes for each Homesite owned. The Class B membership shall cease and be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:
- (a) ninety (90) days after the Developer has conveyed to purchasers seventy five percent (75%) of the Homesites in ANDOVER POINT; or
- (b) when the Developer sends to the Association and each Member thirty (30) days written notice of Developer's intention to turn over control of the Association.

is hereby modified to read as follows:

- Class B: The Class B member(s) shall be the Declarant/Developer (as defined in the Declaration) and shall be entitled to three (3) votes for each Homesite owned. The Class B membership shall cease and be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:
- (a) ninety (90) days after the Developer has conveyed to purchasers seventy five percent (75%) of the total eighty five (85) Homesites in ANDOVER POINT and ANDOVER POINT REPLAT; or
- (b) when the Developer sends to the Association and each Member thirty (30) days written notice of Developer's intention to turn over control of the Association.
- 2. The foregoing amendments were adopted by the members and Directors of the corporation on November 5, 2002.
