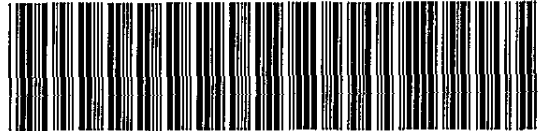

Pursuant to Florida Statutes Section 607.187, the Articles of Incorporation of the above-named Corporation are hereby amended as follows:

1. Article One is hereby amended to read as follows:

ARTICLE ONE: NAME

The name of the Corporation is MOBILE MARINE FUELING, INC.

2. The foregoing amendment was adopted by the unanimous affirmative vote of the Shareholders of the shares entitled to vote thereon, pursuant to Florida Statutes Section 607.187(1), on April 12, 2002. Issued shares of SCOT'S MARINE ENTERPRISES, INC., shall be exchanged for shares of MOBILE MARINE FUELING, INC., with the shares of SCOT'S MARINE ENTERPRISES, INC., to be canceled on the corporate records.


