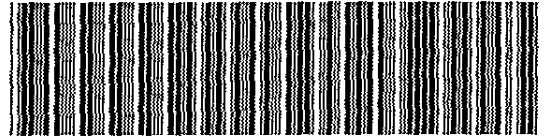

This limited liability company shall commence existence effective November 11, 2002 upon filing these Articles of Organization by the Department of State, the State of Florida, and shall have perpetual existence.

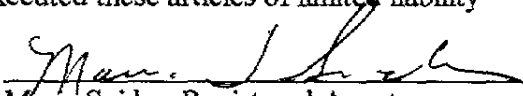

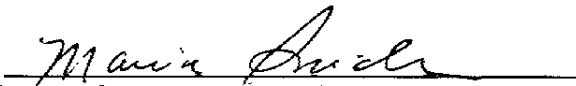
