ARTICLE III

This is a not for profit corporation.

EFFECTIVE DATE

ARTICLE IV

This corporation is organized for the purpose of collecting and disseminating genealogical and historical information for the benefit of its members and others, and to promote interest in the study of genealogy and related historical fields. 
