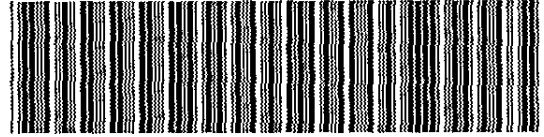

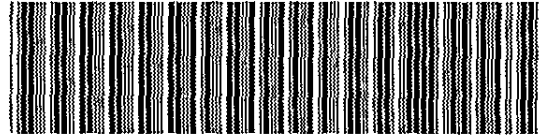

ARTICLES OF ORGANIZATION OF
RABBIT RIDGE PROPERTIES, L.L.C.
A FLORIDA LIMITED LIABILITY COMPANY

THE UNDERSIGNED, MICHAEL G. WADE, constituting all the voting members of RABBIT RIDGE PROPERTIES, L.L.C. (the "Limited Liability Company") pursuant to Florida Statute 608.407 does hereby execute these Articles of Organization of RABBIT RIDGE PROPERTIES, L.L.C. for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act and does hereby state and set forth:

1. The name of the Limited Liability Company is RABBIT RIDGE PROPERTIES, L.L.C.
2. The period of duration of RABBIT RIDGE PROPERTIES, L.L.C. shall be perpetual.
