AMENDMENTS to ARTICLES OF INCORPORATION

Showers of Learning Christian Childcare Center, Inc.

ARTICLE I

Name and Object

Section 1. The name of the corporation shall be: Showers of Learning Christian Childcare Center, Inc., hereinafter referred to as the "Showers of Learning Christian Childcare Center, Inc.", located at 2615 SE 15 Street Gainesville, FL 32641.

Section 2. The purpose of this organization shall be to provide social and human services to meet the needs of the community.

Section 3. Intimacy shall be a non-profit organization under the control and direction of a volunteer Board of Directors.

Section 4. To it purposes, Showers of Learning Christian Childcare Center, Inc. may establish and provide for the conduct and maintenance of its work in one or more sections of the State of Florida, and for particular groups of persons.

Section 5. Showers of Learning Christian Childcare Center, Inc. shall have perpetual existence.

Section 6. The purposes for which Showers of Learning Christian Childcare Center, Inc. are organized is exclusively religious, charitable, scientific, literary, and educational within the meanings of Section 501(c)(3) of the Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue law.

Section 7. Notwithstanding any other provision of these Articles, this organization shall not carry on any other activities not permitted by an organization exempt from 1954,

Section 8 No part of the net earning of the corporation shall insure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distributions in furtherance of Section 501 (c) (3) purpose. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate, or intervene in (including the publishing or distribution of statements) any political campaign of behalf of or in opposition to any candidate for public office.

Section 9 Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.

ARTICLE II

Property

Section 1. Showers of Learning Christian Childcare Center, Inc. may hold or dispose of such property, real or personal, as may be given, divided, or bequeathed to it or entrusted to its care and keeping; may purchase, acquire, and dispose of such property as may be necessary to carry out the purpose of Showers of Learning Christian Childcare Center, Inc.; and may manage, control and utilize the same in accordance with the provisions of Article IV.

Section 2. The highest amount of indebtedness or liability to which Showers of Learning Christian Childcare Center, Inc. may at any time subject itself shall never be greater than two-thirds (2/3) of the value of the assets of Showers of Learning Christian Childcare Center, Inc.

ARTICLE III

Membership

Section 1. Any person who is committed to Showers of Learning Christian Childcare Center, Inc.'s purpose may become a member of this organization, in accordance with such provisions and the Board of Directors may establish classifications as.

Section 2. Any member, eighteen (18) years of age or over, who is committed to the purposes of Showers of Learning Christian Childcare Center, Inc. as defined in Article I, Section 2, and who indicates the willingness to cooperate actively in achieving these purposes, may become a voting member of this organization

Section 3. The responsibilities of voting members shall be:

To help actively in achieving the purpose of Showers of Learning Christian Childcare Center, Inc.;

To comply with the financial and other membership requirements;

To vote, and, if eligible and elected, to hold office;

To represent Showers of Learning Christian Childcare Center, Inc. in national, regional, and local conferences, if and when duly authorized under the stated requirements of such representation.

ARTICLE IV

Management

Section 1. The management of Showers of Learning Christian Childcare Center, Inc. shall be vested in a Board of Directors, consisting of not fewer than seven (7) and not more than fifteen (15) persons, elected by the Board of Directors, or otherwise in such manner and for such terms not exceeding three (3) years, as the Bylaws may provide. The Executive Director is a non-voting member of the Board.

Each director must possess the qualifications for voting membership in Showers of Learning Christian Childcare Center, Inc.:

The Board of Directors shall have and exercise all the powers necessary to control the work and policy of Showers of Learning Christian Childcare Center, Inc. in all its details, including the appointment of Standing and Special Committees. No contract, debt or obligation shall be binding unless contracted under authority of the Board.

The Board of Directors shall have the power to fill, for the unexpired terms, all vacancies occurring in their number between annual elections. They shall have authority to make Bylaws for the governance of Showers of Learning Christian Childcare Center, Inc., not inconsistent with the Articles of Incorporation.

Section 2. The officers of the Board of Directors shall be a President, Vice President, Treasurer, Recording Secretary, and Chaplain, chosen from their own number, as provided for in the Bylaws. These shall also be the officers of Showers of Learning Christian Childcare Center, Inc.

ARTICLE V

Meetings of Showers of Learning Christian Childcare Center, Inc.

Section 1. There shall be an Annual Meeting of Showers of Learning Christian Childcare Center, Inc. within 90 days after the close of the fiscal year, at which time the Board of Directors shall report to the membership the status of the organization. Notice of this meeting shall be given to all voting members by publication or by mail at least two (2) weeks in advance.

Section 2. Showers of Learning Christian Childcare Center, Inc. shall hold such other meetings of the organization as may be provided for in the Bylaws.

Section 3. Special meetings of Showers of Learning Christian Childcare Center, Inc. may be called by the President or by order of the Board of Directors. Upon written request of one-half of the voting membership of Showers of Learning Christian Childcare Center, Inc., the President or the Recording Secretary shall call a meeting specifying the object, which shall be incorporated in the notice. A notice of such meeting shall be mailed to every voting member at least seven (7) days in advance of the meeting. No business shall be transacted at such meeting, except that for which the call is issued.

Section 4. One-third (1/3) of the voting membership shall constitute a quorum at any meeting called by the voting members of this Showers of Learning Christian Childcare Center, Inc..

Section 5. A written record of the attendance and business transacted at all regular and special meetings of Showers of Learning Christian Childcare Center, Inc. shall be maintained and filed with the Minutes of the Board of Directors.

ARTICLE VI

Dissolution

Section 1. Upon dissolution of this corporation, the Board of Directors, after paying or making provisions for the payment of liabilities of the corporation pursuant to operational law, shall distribute all assets exclusively to those organizations which are exempt under Section 501(c)(3) of the Internal Revenue Code, provided that this corporation retains discretion and control over the terminal use of said contributions prior to dissolution.

ARTICLE VII

Amendments

Section 1. The Articles of Incorporation may be amended by vote of one-third (1/3) of the Board of Directors present at any regularly constituted meeting of Showers of Learning Christian Childcare Center, Inc., provided such amendment shall have been submitted by the Board of Directors.
