**ARTICLE I
NAME OF COMPANY**

The name of this corporation shall be:

AMAZON VISION MINISTRIES, INC.

**ARTICLE II
PURPOSES FOR WHICH THE CORPORATION IS ORGANIZED**

This corporation shall be a not for profit corporation organized and existing under the provisions of Chapter 617, Florida Statutes, as the same may be hereafter lawfully renumbered or amended. The purpose of this corporation shall be:

To bring the Good News of salvation through Jesus Christ alone to the people of Central and South America by providing a transportation network to facilitate the work of short term volunteer mission teams and on-site missionaries.

ARTICLE V MANNER OF ELECTION OF DIRECTORS

The method of election of the Directors of this corporation and the number of the Directors of this corporation shall be provided in the by-laws of the corporation except there shall not be less than one (1) Director and no more than nine (9) Directors.

ARTICLE VI RESTRICTIONS

All of the assets and income of the corporation shall be used only for the purposes described in these Articles of Incorporation, including the payment of expenses incident thereto. No part of the net earnings of the corporation shall inure to the benefit of any private member or individual or any director or officer of the corporation. No substantial part of the activities of the corporation shall be for the carrying on of propaganda or otherwise attempting to influence legislation nor shall the corporation participate in any political campaign on behalf of (or in opposition to) any candidate for public office.

**ARTICLE VII
DISPOSITION OF CORPORATE ASSETS UPON DISSOLUTION**

Upon dissolution of this corporation, after all of the corporation's debts and other obligations have been paid or provided for, all of the then remaining assets of the corporation not used for such purposes will be donated, assigned and transferred and conveyed to one or more organizations then described in Section 501(c)(3) of the Internal Revenue Code chosen and designated by the corporation's Board of Directors and in such shares or proportions as shall be determined by the Board of Directors.

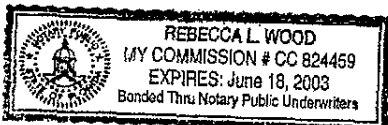

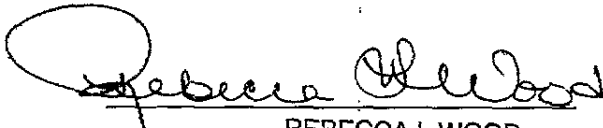
