

## ARTICLES OF INCORPORATION OF SUNSET VILLAGE CONDOMINIUM ASSOCIATION, INC.

(A NON-PROFIT FLORIDA CORPORATION)

#### ARTICLE I.

The name of this corporation is SUNSET VILLAGE CONDOMINIUM ASSOCIATION, INC. The initial principal office of the corporation is 209 Boundary Boulevard, Rotonda, Florida 33947, and the initial mailing address of the corporation is 685 Harvey Street, Englewood, Florida 34223.

#### ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed Sunset Village of Rotonda West, a Condominium, located in Charlotte County, Florida, and to operate property owned by the Association.

#### ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of Sunset Village of Rotonda West, a Condominium.

#### ARTICLE IV.

The qualification of members and the manner of their admission shall be as follows: Any person or persons who hold title in fee simple to a condominium unit in Sunset Village of Rotonda West, a Condominium, shall by virtue of such ownership be a member of this corporation.

#### ARTICLE V.

This corporation shall exist perpetually.

The affairs of the corporation are to be managed by a Board of Directors, the number of members of which shall be as provided in the Bylaws provided that there shall be not fewer than three and not more than seven. The Bylaws of the corporation are to be made, altered or rescinded by the members of the corporation as provided for in the Bylaws.

#### ARTICLE XI.

Amendments to these Articles of Incorporation may be proposed and adopted at any regular or specially called meeting of the members of the Association by a majority vote of all the members. Due notice of the meeting must have been given as provided for in the Bylaws. Also, the Developer may amend these Articles of Incorporation, and its approval shall be required for amendments, in the manner provided in the Sunset Village of Rotonda West Declaration of Condominium.

#### ARTICLE XII.

Each unit in Sunset Village of Rotonda West, a Condominium shall have one (1) full vote, which shall be cast by a designated owner as provided for in the Declaration of Condominium or Bylaws.

#### ARTICLE XIII.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation.

#### ARTICLE XIV.

No part of the net earnings of this corporation shall inure to the benefit of any member or individual, except through the acquisition, construction, management, maintenance, or care of association property or through the rebate of the excess membership dues, fees, or assessments.
