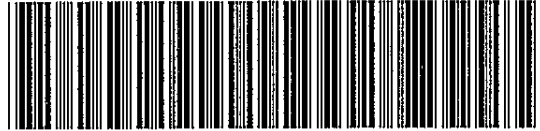



ARTICLE ONE

The name of the corporation is ~~AG~~ A TOP TO BOTTOM HOME INSPECTION AND CONSULTING SERVICE, INC. The principal office of the corporation is 2500 Florida Avenue S., St. Petersburg, Florida 33705.

The period of duration is perpetual.

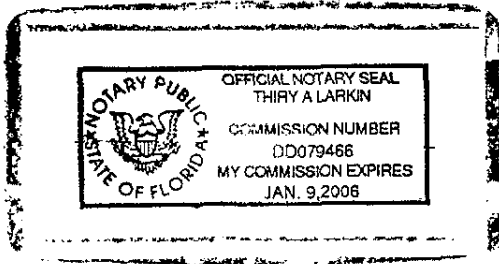
