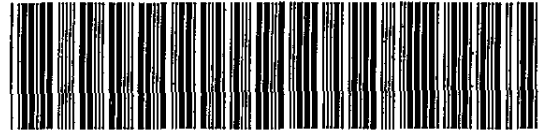



The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I
Name of the Corporation

The name of this corporation is Daniel's Electric Company, Inc.

ARTICLE II
General Purpose

This corporation is organized for the purpose of commercial and residential electrical installation and repairs. The corporation may transact any and all other lawful business for which corporations may be incorporated under the Florida General Corporation Act.


**ARTICLE VIII

Tax Status**

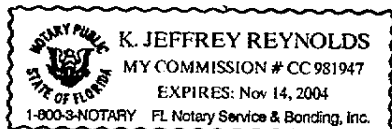
The corporation intends to elect to be treated as an S Corporation under the Internal Revenue Code.
