ARTICLE V -- INITIAL REGISTERED OFFICE

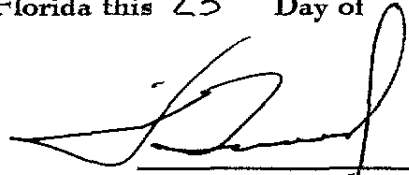

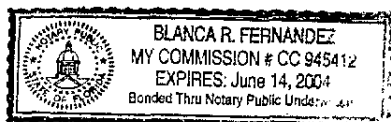
