ARTICLES OF ORGANIZATION OF Seminole/Irish, LLC

The undersigned Organizers/Organizing Members to this Articles of Organization, hereby form a limited liability company under the Laws of the State of Florida and Chapter 608 of the Florida Statutes.

<u>ARTICLE I - NAME</u>

The name of the limited liability company shall be **Seminole/Irish**, **LLC**, a Florida limited liability company.

ARTICLE II – DURATION

The period of the limited liability company's existence shall be perpetual.

A. <u>Right of Substitution</u>. The right of a Member to substitute an assignee as contributor in his or her place, and the terms and conditions of the substitution are as follows:

IN THE LIMITED LIABILITY COMPANY

- A fully executed and acknowledged written instrument of assignment must be filed with the Managers setting forth the intention of the assignor that the assignee become a member in his or her place;
- 2. - B. <u>Admission of Additional Members.</u> The Managers of this limited liability company has the right to admit additional members in their sole discretion.

- C. Termination of Membership of a Member. The membership of a Member in this limited liability company may only be terminated upon the occurrence of any of the following events: death, retirement, resignation, bankruptcy or dissolution of a member or the occurrence of any other event which terminates the continued membership of a Member of this limited liability company. Upon the termination of a Member's membership in this limited liability company.
