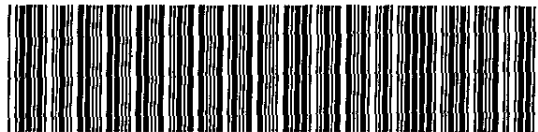



Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its Articles of Incorporation.

FIRST: Amendment adopted: ARTICLE I of the Articles of Incorporation of Animed, Inc. shall be amended as follows:

ARTICLE I

The name of the corporation shall be VETIMED, INC.

SECOND: The Articles of Amendment shall be effective when filed with the Department of State.
