ARTICLES OF AMENDMENT OF NEXSYS COMPUTER SERVICES, INC.

BATES, being the Incorporator of NEXSYS COMPUTER SERVICES, INC., does hereby certify that the following Amendment to the Articles of Incorporation of NEXSYS COMPUTER SERVICES, INC., was approved by the Stockholder of said Corporation on the 19th day of January, 2004, at a duly called meeting of the Stockholder and Director of the Corporation.

The Articles of Incorporation of NEXSYS COMPUTER SERVICES, INC. are hereby amended as follows:

Article IX of the Articles of Incorporation is hereby amended as follows:

1. The number of Directors of the Company shall be one (1) and may be increased or diminished from time to time, by a vote of the then acting Director or Directors by majority rule when approved by the Stockholders, but shall never be less than one (1).
