ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF AGAPA OUTREACH, INC.

04 FILED A 208

The undersigned, Larry J. Anderson, being the President of Agapa Outreach, Inc., a Florida not-for-profit corporation, does hereby certify that a special meeting of the Board of Directors of said corporation was duly held at Lakeland, Florida, on the 28th day of December, 2003.

RESOLVED, that the Articles of Incorporation be, and the same are hereby, amended so that Article III is deleted in its entirety and the following Article III is substituted therefor:

The general nature of the objectives and goals of this non-profit corporation are:

- (a) To attend to the physical, emotional, social and financial needs of individuals and families of deprived communities of Polk County, Florida;
- (b) To acquire and provide buildings and facilities in these communities to use as a base for organizing and implementing programs:
- (c) To provide counseling and support within the communities where the people live, most of the time in walking distance of their homes;
- (d) To provide food, clothing, home supplies, and other physical needs where possible;
- (e) To provide extended health care programs for children and adults of the communities with regard to diet, exercise and physical health;
- (f) To provide educational training, tutoring and emotional support for school children:
- (g) To provide educational training, tutoring and emotional support for adults to assist them in finding or maintaining employment;
- (h) To provide financial planning, training and instruction to assist people of the communities in maintaining checking and bank accounts as well as paying bills and keeping proper financial records;
- (i) To provide an environment for emotional and psychological strength and healing for children, youth and adults of these targeted communities;
- (j) To see the communities elevated in appearance and position with hands on training for home, yard and neighborhood improvement projects;
- (k) To plan and execute various weekly activities to accomplish our goals;
- (1) Ultimately, our goal is to improve the quality of life of all those in the community.

There are no members or members entitled to vote on the amendment. The amendment was adopted by the Board of Directors.
