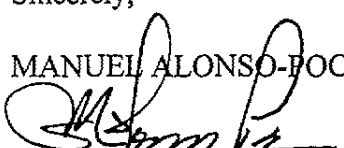

**THIRD:**

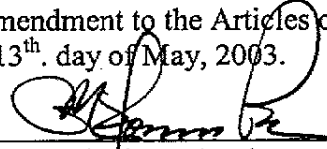
The date of the amendment's adoption is May 13, 2003.

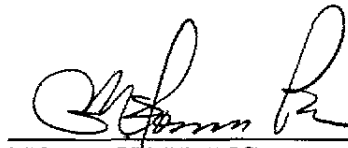
