**ARTICLES OF INCORPORATION**

**ARTICLE I - NAME AND ADDRESS**

The name of this corporation is **STF CONSULTING, INC.** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 5762 N. W. 98<sup>th</sup> Court, Miami, Florida 33178.
