### Articles of Incorporation For Above All Names, Inc.

SECRETARY OF STATE I, the undersigned Incorporator, being a natural person competent to contract, hereby organizes and incorporates under the laws of the State of Florida a corporation not for profit as follows:

### **ARTICLE I: Name**

The name of the corporation shall be Above All Names, Inc.

### **ARTICLE II: Principle Office**

The principle place of business of the corporation shall be 14843 68<sup>th</sup> Street North, Loxahatchee, Florida 33470.

### **ARTICLE III: Purpose**

The corporation shall be a not for profit corporation. The purpose for which the corporation is organized is to offer the Body of Christ prayer strategies through God's Word, historical research and current events for the purpose of transformation and revival in cities and nations so that the name of Jesus would be exalted above all names. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The power of this corporation shall be exercised, its properties controlled and its affairs conducted by a Board of Directors. The period of this corporation is perpetual unless dissolved according to law.

### **ARTICLE IV: Manner of Election**

This corporation shall have an initial Board of Directors of three (3). The number of directors may be either increased or diminished from time to time based upon the majority vote of Board, but the number of Directors shall, subject to ARTICLE VII below, never be less than three (3) nor more than seven (7).

### **ARTICLE V: Initial Directors/Officers**

The number constituting the initial Board of Directors of the corporation is three (3). The number of directors may be either increased or diminished from time to time but the number shall never be less than three (3) nor more than seven (7). The manner in which directors will be elected and/or appointed shall be enumerated in the bylaws adopted at the organizational meeting. The names and addresses of the persons who are to serve initially are:

Any action required or permitted to be taken by the Board of Directors under any provision of law may be taken without a meeting, if all members of the Board shall individually or collectively consent in writing to such action. Such written consent or consents shall be filed with the minutes of the proceedings of the Board, and any such action by written consent shall have the same force and effect as if taken by unanimous vote of the Directors without a meeting, and that the Articles of Incorporation and the By-laws of this Corporation authorized the Directors to so act. Such a statement shall be prima facie evidence of such authority.

### **ARTICLE VI**

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of the statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

### ARTICLE VII: Dissolution

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court Of Competent Jurisdiction of the county in which the principal office of the

corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated for such purposes. 04 M/R - 9 SECRETAR
