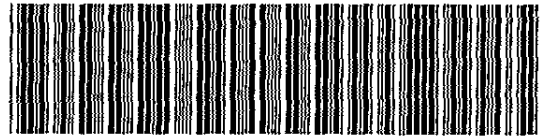



**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida not for profit corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** The Amendment adopted is as follows:

\* \* \*

**ARTICLE VII. BOARD OF DIRECTORS**

A. The business affairs of this Association shall be managed by the Board of Directors who ~~need not~~ **shall** be Members of the Association. The number of members of the first Board of Directors shall be three and the initial Board of Directors shall be appointed by the Declarant. **Thereafter, the affairs of the Association shall be managed by a Board consisting of an odd number of Directors between three (3) and nine (9) members, the number of which shall be set by the Board no later than thirty (30) days prior to the annual meeting of the members, provided that no change may operate to prematurely end the term of a sitting director. In keeping with Article VII (C) hereof, the terms of the Directors shall be staggered with (as nearly as possible), an equal number of positions becoming available for election each year for a term of three (3) years. The Board shall be empowered to establish by rule a system of elections to ensure that staggered terms are maintained, provided that in all instances the person receiving the highest total of votes shall be elected to the longest term available, and tie votes occurring in connection with the election of Directors shall be broken by the drawing of lots or a similar random device.**

\* \* \*

**ARTICLE IX. BYLAWS**

A. The Board of Directors shall adopt by a majority vote the original Bylaws of the Association.

B. The Bylaws shall be amended by the procedure more fully set forth in the Bylaws and shall be approved by at least a majority of each class of membership **who are present and voting in person or by proxy at a duly called meeting of the membership at which a quorum is present.**

**SECOND:** The foregoing amendment was adopted by written consent in lieu of a meeting of the members. The written consents were received between March 6, 2004 and March 15, 2004.

**THIRD:** The amendment was proposed by majority of the Board of Directors and the amendment was adopted by the affirmative written consent of not less than seventy-five percent (75%) of the members.
