ARTICLES OF INCORPORATION FOR 407 BIF COURT CONDOMINIUM ASSOCIATION, INC.

The undersigned incorporators hereby file these Articles of Incorporation for the purpose arming a corporation not-for-profit pursuant to Chapter 617, Florida Statutes, as amended.

ARTICLE I NAME

The name of the corporation shall be 407 BIF COURT CONDOMINIUM OCIATION, INC. For convenience, the corporation shall be referred to in this instrument as "Association," these Articles of Incorporation as the "Articles," the Declaration of dominium for 407 Bif Court Condominium as the "Declaration" and the Bylaws of the ociation as the "Bylaws."

ARTICLE II PURPOSE

In accordance with the provisions of Chapter 718, Florida Statutes, the "Condominium" a condominium will be created upon certain lands in Orange County, Florida, to be known 07 Bif Court Condominium (the "Condominium") according to a Declaration to be recorded to Public Records of Orange County, Florida. This corporation is organized for the purpose operating, governing, administering and managing the property and affairs of the dominium and to exercise all powers and discharge all responsibilities granted to it as a toration under the laws of the State of Florida, the Bylaws and the Condominium Act, and to tire, hold, convey and otherwise deal in and with real and personal property in the poration's capacity as a condominium association.

ARTICLE III DEFINITIONS

The terms used in these Articles shall have the same definitions and meanings as those forth in the Declaration, the Bylaws and as provided by Florida Statutes unless herein ided to the contrary, or unless the context otherwise requires.

ARTICLE IV PRINCIPAL OFFICE AND MAILING ADDRESS

The mailing address of the Corporation is 407 Bif Court, Orlando, Florida 32809. The cipal office of the corporation is 407 Bif Court, Orlando, Florida 32809.

ARTICLE V POWERS AN DUTIES

The powers of the corporation shall include and be governed by the following:

- 5.1 <u>General</u>. The corporation shall have all of the common-law and statutory powers a corporation not for profit under the Laws of Florida that are not in conflict with the visions of these Articles and the Declaration, and all the powers conferred by the idominium Act upon a condominium association and all the powers set forth in the laration which are lawful.
- 5.2 <u>Enumeration</u>. This Association shall have all of the powers and duties set forth in appropriate Florida Statutes except as limited by these Articles and the Bylaws, and all of the rers and duties reasonably necessary to operate the Association as more particularly described he Bylaws, as they may be amended from time to time, including, but not limited to, the pwing:
 - (a) To operate and manage the Condominium and Common Elements.
 - (b) To make and collect Assessments and other charges against Association members and to use the proceeds thereof in the exercise of its powers and duties.
 - (c) To buy, own, operate, lease, sell, trade and mortgage both real and personal property.
 - (d) To maintain, repair, replace and operate the Common Elements.
 - (e) To purchase insurance upon the Property and insurance for the protection of the Corporation, the Association, its officers, directors and Owners. To reconstruct improvements upon the Property after casualty and to further improve the property.
 - (f) To make and amend reasonable rules and regulations for the maintenance, conservation and use of the Property and for the health, comfort, safety and welfare of the Owners.
 - (g) To enforce by legal means the provisions of Florida Statutes as they may apply, these Articles, the Bylaws, and the rules and regulations for the use of the Property, subject, however, to the limitation regarding assessing Units owned by the Declarant for fees and expenses relating in any way to claims or potential claims against the Declarant as set forth herein and/or in the Bylaws.
 - (h) To contract for the management and maintenance of the Property and to authorize a management agent to assist the Association in carrying out its powers and duties by performing such functions as the submission of proposals, collection of Assessments, preparation of records, enforcement of rules and maintenance, repair and replacement of the Common Elements with such funds as shall be made available by the Association for such purposes. The Association and its officers shall, however, retain at all times the powers and duties granted by these Articles, the Bylaws and Florida Statutes, including, but not limited to, the making of Assessments, promulgation of rules and execution of contracts on behalf of the Association.

- (i) To employ personnel to perform the services required for the proper operation of the Association.
- 5.3 <u>Association of the Property</u>. All funds and the title to all properties acquired by Association and their proceeds shall be held for the benefit and use of the Owners in ordance with the provisions of the Declaration, these Articles and the Bylaws.
- 5.4 <u>Distribution of Income</u>, <u>Dissolution</u>. The Association shall make no distribution acome to its members, directors or officers, and upon dissolution, all assets of the Association 1 be transferred only to another nonprofit corporation or a public agency.
- 5.5 <u>Limitation</u>. The powers of the Association shall be subject to and shall be cised in accordance with the provisions hereof and of the Bylaws and appropriate Florida utes.

ARTICLE VI MEMBERS

- 6.1 <u>Membership</u>. Membership in the Association may only be issued or transferred to record title owner(s) of Units in 407 Bif Court Condominium. Each Owner of a Unit shall be ember. Any member may own more than one Unit.
- 6.2 <u>Assignment</u>. The rights, titles, duties and responsibilities of a member in the ociation cannot be assigned, hypothecated or transferred in any manner except as an artenance to the Unit for which that Unit is held.
- 6.3 <u>Voting</u>. On all matters upon which the membership shall be entitled to vote, ng rights shall be exercised as provided in the Declaration.
- 6.4 <u>Meetings</u>. The Bylaws shall provide for an annual meeting of members, and may e provision for regular and special meetings of members other than the annual meeting.

ARTICLE VII TERM OF EXISTENCE

Existence of the Association shall commence with the filing of these Articles of rporation with the Florida Department of State. The Association shall exist in perpetuity.

The Bylaws may provide for the noval from office of officers, for filling vacancies and for the duties of the officers. ARTICLE X DIRECTORS

- 10.1 <u>Number and Qualification</u>. The property, business and affairs of the Association all be managed by a board consisting of the number of directors determined in the manner ovided in the Bylaws.
- 10.2 <u>Duties and Powers</u>. All of the duties and powers of the Association and these ticles and the Bylaws shall be exercised exclusively by the Board of Directors, its agents, ntractors or employees, subject only to approval by Owners when such approval is specifically quired.

ARTICLE XI INDEMNIFICATION

- 11.1 Indemnify. The Association shall indemnify any person who was or is a rty or is threatened to be made a party to any threatened, pending or contemplated action, suit proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that is or was a director, employee, officer, or agent of the Association, against expenses cluding attorneys' fees and appellate attorneys' fees) judgments, fines and amounts paid in tlement actually and reasonably incurred by him in connection with such action, suit or occeding, unless (a) a court of competent jurisdiction determines, after all available appeals ve been exhausted or not pursued by the proposed indemnitee, that he did not act in good faith, r in a manner he reasonably believed to be in or not opposed to the best interest of the sociation, and with respect to any criminal action or proceeding, that he had reasonable cause believe his conduct was unlawful, and (b) such court further specifically determines that The termination of any action, suit or proceeding by lemnification should be denied. Igment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent shall t, of itself, create a presumption that the person did not act in good faith and in a manner in iich he reasonably believed to be in or not opposed to the best interest of the Association, and th respect to any criminal action or proceeding, had reasonable cause to believe that his nduct was unlawful.
- 11.2 <u>Expenses</u>. To the extent that a director, officer, employee or agent of the sociation has been successful on the merits or otherwise in defense of any action, suit or beceding referred to in Section 11.1 above, or in defense of any claim, issue or matter therein, shall be indemnified against expenses (including attorneys' fees and appellate attorneys' fees) tually and reasonably incurred by him in connection therewith.
- 11.3 Advances. Expenses incurred in defending a civil or criminal action, suit proceeding shall be paid by the Association in advance of the final disposition of such action, it or proceeding upon receipt of an undertaking by or on behalf of the affected director, officer,

bloyee, or agent to repay such amount unless it shall ultimately be determined that he is tled to be indemnified by the Association as authorized in this Article.

- Miscellaneous. The indemnification provided by this Article shall not be med exclusive of any other rights to which those seeking indemnification may be entitled er any bylaw, agreement, vote of members or otherwise, and shall continue as to a person has ceased to be a director, officer, employee or agent and shall inure to the benefit of the s and personal representatives of such person.
- 11.5 <u>Insurance</u>. The Association shall have the power to purchase and maintain trance on behalf of any person who is or was a director, officer, employee or agent of the ociation, or is or was serving, at the request of the Association, as a director, officer, ployee or agent of another corporation, partnership, joint venture, trust of other enterprise, not any liability asserted against him and incurred by him in any such capacity, or arising out its status as such, whether or not the Association would have the power to indemnify him not such liability under the provisions of this Article.
- 11.6 <u>Amendment</u>. Anything to the contrary herein notwithstanding, the risions of this Article may not be amended without the prior written consent of all persons see interest would be adversely affected by such amendment.

ARTICLE XII BYLAWS

The first Bylaws of the Association shall be adopted by the Board of Directors and may Itered, amended or rescinded in the manner provided in the Bylaws.

ARTICLE XIII AMENDMENTS

Amendments to the Articles of Incorporation require the approval of at least two-thirds) vote of the voting interests in the Corporation.

ARTICLE XIV DISSOLUTION

The Corporation may be dissolved as provided by Florida law. Upon dissolution of the poration, other than incident to a merger or consolidation, the assets of the Corporation shall ledicated to a public body, or conveyed to a non-profit organization with similar purposes, in ordance with applicable law.
