#### ST. MANUEL CORPORATION

The undersigned Incorporator hereby executes, acknowledges and the with the Florida Department of State the following Articles of Incorporation (the "Articles") for the purpose of organizing a corporation pursuant to Chapter 607, Florida Statute (the "Act").

#### ARTICLE I - Name

# ARTICLE II - Principal Office
