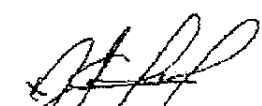
## ARTICLE XI

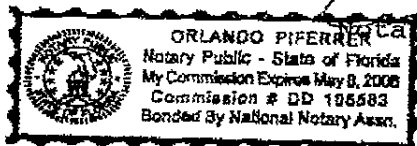
