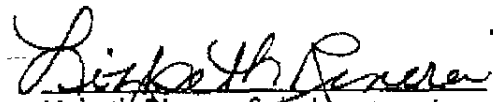
ARTICLES OF INCORPORATION

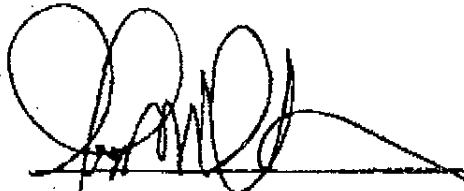
