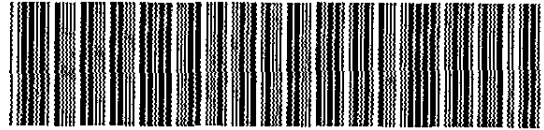

Article I **NAME**

The name of the corporation shall be *The X-Factor Motorcycle Club Incorporated.*

Article II **PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

Article III **PURPOSE**

The purpose for which the corporation is organized is to encourage, organize and promote the sport of motorcycling, social and competitive events, and a better image thereof to the general public.

Article IV **MANNER OF ELECTION**

The affairs of The X-Factor Motorcycle Club shall be conducted by the Executive Board, which will be elected at the Annual General Meeting (AGM). The Executive Board is comprised of the following:

President - who shall hold office for the duration of the organization's existence.

Vice President - who shall hold office for two (2) consecutive years and be eligible for re-election.

Secretary - who shall hold office for two (2) consecutive years and be eligible for re-election.

Treasurer - who shall hold office for two (2) consecutive years and be eligible for re-election.

Conveners - who shall hold office for two (2) consecutive years and be eligible for re-election.

The membership will consist of a minimum (additional to the E-Board) of twelve (12) members—six (6) of which will hold active membership status for two (2) consecutive years and another six (6) will hold active membership status for one year. Both groups will be eligible for re-election. The

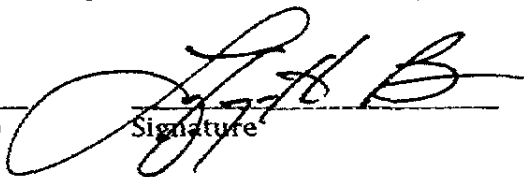

organization's secretary and a minimum of two (2) club directors will be nominated by the E-Board from the general body in "good standing."

Article V

MANNER OF MEMBERSHIP TERMINATION

Termination of membership status may be acquired via three (3) alternatives. Officers and members of this corporation may terminate their membership voluntarily, be requested by organization's President to resign, or be expelled from the organization by the organization's President.

Upon termination of membership of the organization, members are to participate in a formal hearing with the organization's President and other officers if deemed necessary by the organization's President. Members to be terminated will be given the opportunity to have any questions asked or concerns addressed at that time. Remaining organization members and officers will be informed appropriately of the revised organization's membership roster.

Membership status may not be transferred to any other motorcycle club. Formal termination from The X-Factor Motorcycle Club must be achieved before any former member may be acknowledged as a member or another motorcycle club.

If for any reason an office bearer or E-Board member shall cease to act during his or her term of office, a successor shall be appointed by the E-Board and shall hold office until the next AGM.

Article VI

DISTRIBUTION OF ASSETS

The distribution of assets upon dissolution, final liquidation, or if otherwise permitted by law, upon partial liquidation will be donated to another not for profit organization with a similar mission, to a charity of the organization's preference, or at the discretion of the E-Board. Such final decision will be made during a sanctioned AGM or an Extra-Ordinary General Meeting (EOGM).
