ARTICLE I - NAME

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The name of this componation is: REGENCY FLOORING CONTRACTORS, CORP.

ARTICLE II - DURATION

This componation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incomponation by the initial subscribers.

ARTICLE III - PURPOSE .
