WHEREAS, the corporate name was amended on March ⁵~~8~~, 2004 from Shapiro of Sarasota, Inc., to Armand Lewis Shapiro, P.A.;

WHEREAS, the undersigned ARMAND L. SHAPIRO, is the President of said corporation, which corporation has no directors, and one shareholder as of this date, and

WHEREAS, it is the intent of the undersigned as its only officer and incorporator, to amend the Articles of Incorporation of ARMAND LEWIS SHAPIRO, P.A., in order to change the purpose of said corporation to and to comply with the provisions of Florida Statute 621.04.

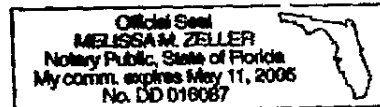
