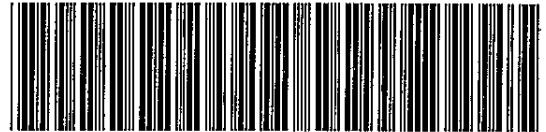

*ARTICLE IX. - INCORPORATOR(S)*






