On April 22, 2004, our accountant began preparation for the Annual Report for the Miami Bayside Foundation. She attempted to download the form on the internet but could not do so because the corporation showed inactive. She proceeded to notify me and I contacted your office immediately to inquire on the matter. I explained to a very courteous young lady named Ruby what we had gone through the previous year and that we had done everything that had been requested however, apparently our efforts had been in vain since we were facing the exact same situation again this year. She looked at our file and advised me that we had been sent a request to correct a form and had not been returned. I advised her that no such form had been received in the office and that I would have acted upon it immediately due to the delicate nature of the issue and the awareness that already existed. To Whom It May Concern:

On October 29, 2003, I received a phone call from your office stating that the Department of Financial Services had forwarded my request for a change in the Secretary to the Miami Bayside Foundation and that at this time our corporation was inactive because the 2003 Annual Uniform Business Report had not been received. Your office also informed me that the report was due in April of this year and that the corporate registration had just expired in September. I informed the young lady that we had moved twice in one year and that maybe this was the cause of the problem but that I would check with our accountant on the status of this issue. The young lady (unfortunately I did not get her name) then informed me that if the cause was that we did not receive the form she would send me a new form and upon completion I should resubmit it with all of the changes and the appropriate check, along with a letter stating that I had not received the form and that all would be reinstated.

Subsequently, I contacted our accountant and she advised me that the UBR had been sent in April and that she would get me copies of the form and the cancelled check so that we could correct this issue immediately.
