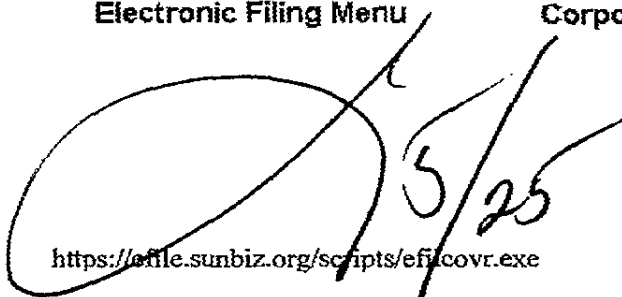

SHARES

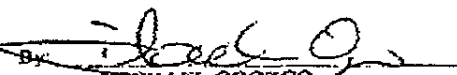

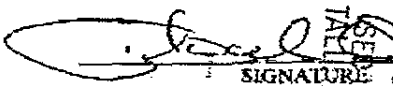
