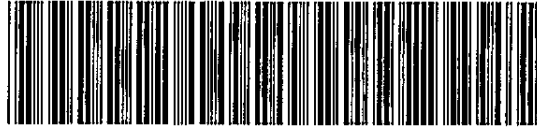

The undersigned, being authorized to execute and file these Articles, hereby certifies that:

ARTICLE I - Name:

The name of the Limited Liability Company is: **DOMAIN HOMES, LLC** (hereinafter the "Company").

ARTICLE II - Address:
