

ARTICLES OF ORGANIZATION OF

351 Springline, LLC, a Florida Limited Liability Company

ALLANDER FORMORS The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company shall be 351 Springline, LLC, a Florida limited liability company (the "Company").

ARTICLE II PRINCIPAL PLACE OF BUSINESS
