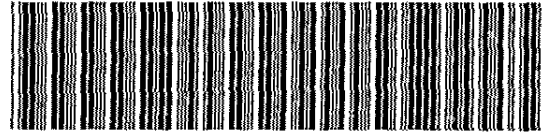

**ARTICLES OF INCORPORATION

The corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one. The director namely shall be:


