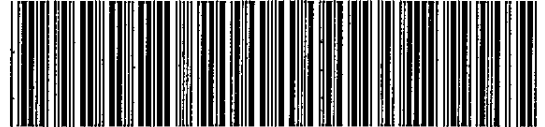

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Article I

The name of the corporation is: **Hometown Barbers, Inc.** The principal place of business of this corporation shall be 338 Boxwood Drive, Davenport, FL 33837.

Article II

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, or country.

Article III

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.

Article IV

The street address of the initial registered office shall be 338 Boxwood Drive, Davenport, FL 33837 and the name of the initial registered agent of the corporation at that address is Anthony J. Roma.

Article V

The corporation is to exist perpetually.

Article VI

This corporation shall have one (1) Director initially. 
Article X

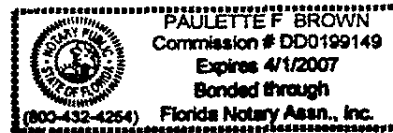
