## **ARTICLE I**

The name of this corporation is:

# **ARTICLE II**

The general nature of the business to be transacted by this corporation is:

- 1. Martial Arts Teaching and Training.
- Ali lawful purposes.
- 3. To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property and services of every class, kind and trust, insurance, surety, express, railroad, canal, telegraph, telephone or cemetery company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition.
