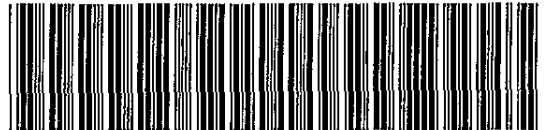

ARTICLES OF INCORPORATION OF
THE NE 199TH STREET SENIOR COMMUNITY CENTER, INC.
(A not-for-profit corporation)

Pursuant to the provisions of Section 627.1006, Florida Statutes, the undersigned, on behalf of The NE 199th Street Senior Community Center, Inc, a Florida non-profit corporation which were filed on November 10, 2003, hereby adopts the following Amendment to its Articles of Incorporation:

1. Article III is hereby amended to read as follows:

ARTICLE III
PURPOSE

The corporation is organized exclusively for charitable, educational, religious or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

The corporation will own and operate a senior community center for the low to middle income residents of Miami-Dade County, Florida and to provide an alternative where they may make friends, be stimulated intellectually, physically and receive a nourishing meal.

2. Article VIII is hereby added to read as follows:

ARTICLE VIII
DISSOLUTION

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose as determined by the Board of Directors. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

3. The foregoing amendment was adopted by unanimous consent at a meeting of the members held on June 24, 2004.

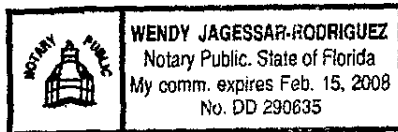
