As used herein the following shall apply:

II.

ARTICLES OF INCORPORATION

1. Article X of the Articles of Incorporation shall be amended to read as follows:

"X

BY-LAWS

The By-Laws of the Condominium Association shall be adopted by the First Board, and thereafter may be altered, amended or rescinded by the affirmative vote of not less than a majority of the total votes of all Members cast at a regular or special meeting of the Membership and the affirmative approval of a majority of the Board of Directors at a regular or special meeting of the Board of Directors.
