**ARTICLES OF AMENDMENT OF
ARTICLES OF ORGANIZATION OF
SIGNAL ONE RESP ORG, LLC**

The undersigned, for the purpose of amending the Articles of Organization of SIGNAL ONE RESP ORG, LLC, a limited liability company formed and existing under the laws of the State of Florida, adopts the following Articles of Amendment pursuant to Section 608.411, Florida Statutes:

ARTICLE I - NAME

ARTICLE II - DATE OF FILING OF ARTICLES OF ORGANIZATION

Article VII of the Articles of Organization is hereby deleted in its entirety and replaced with the following:

**Article VII
Management**

Section A. Management. The limited liability company is to be manager managed in accordance with the Operating Agreement of the limited liability company, as amended.

ARTICLE IV - DATE OF ADOPTION

The foregoing amendments to the Articles of Organization were adopted on the 5th day of January, 2004, by a unanimous vote of the members. The number of votes cast for the amendment was sufficient for approval.
