*Pursuant to the provisions of section 617.1006, Florida Statutes, DCP Condominium Association, Inc., a Florida non-profit corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:*

**FIRST:** Article 2 is deleted in its entirety and replaced with the following:

**ARTICLE 2 – OFFICE**

The principal office and mailing address of the Association shall be at: 2977 McFarlane Road, Unit 303, Miami, Florida 33133, or at such other place as shall be subsequently designated by the Board of Directors. All books and records of the Association shall be kept at its principal office or at such other place as may be permitted by the Act.

**SECOND:** Article 9 is deleted in its entirety and replaced with the following:

**ARTICLE 9 – OFFICERS**

The affairs of the Association shall be administered by the officers holding the offices designated in the By-Laws. The officers shall be elected by the Board of Directors of the Association at its first meeting following the annual meeting of the members of the Association and shall serve at the pleasure of the Board of Directors. The By-Laws may provide for the removal from office of officers, for filling vacancies and for the duties and qualifications of the officers. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows:

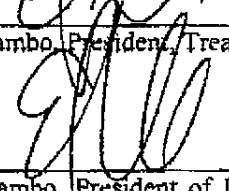

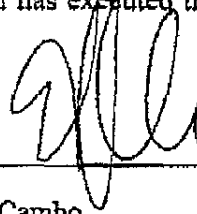
