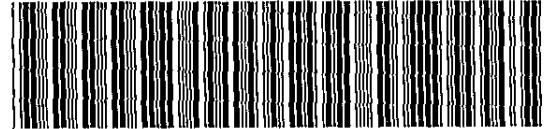

**NAME**

The name of the Corporation is **MINCHEW & SON, INC.**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

### **INDEMNIFICATION**



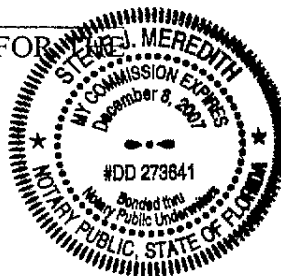
