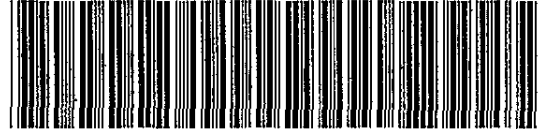

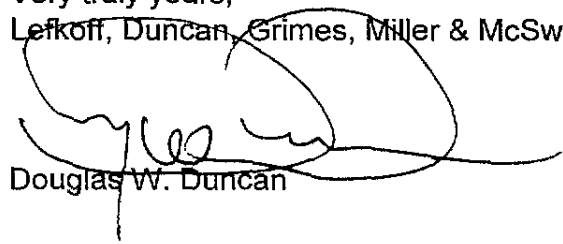

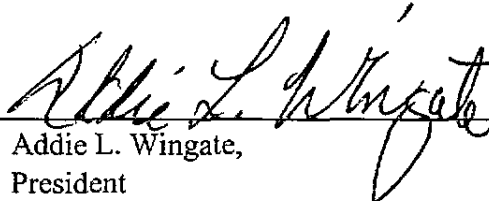

1. The name of the corporation is American Die Supplies, Inc.
