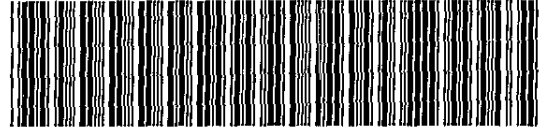

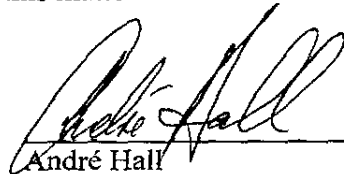

**RESTATED ARTICLES OF INCORPORATION
OF
BIG CITY TITLE, INC.**

Pursuant to Section 607.1007 of the Florida Business Corporation Act, the Articles of Incorporation of Big City Title, Inc. (the "Corporation") are hereby amended and restated to read in its entirety as follows:

**ARTICLE I
NAME**

The name of the Corporation is Hall Consulting, Inc.

**ARTICLE II
PRINCIPAL OFFICE AND MAILING ADDRESS**

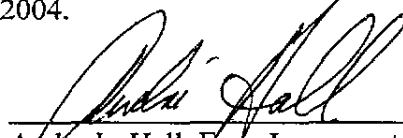
ARTICLE VII
