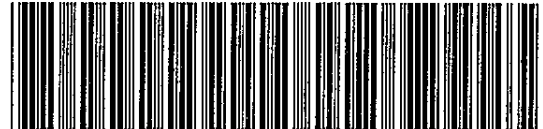

Article V. Initial Directors and/or Officers


The initial director and president shall be the founder, Christine Ottens. Christine Ottens address is 3350 Stone Street, Oviedo, FL 32765.

Article VII. **Incorporator**


