SECOND: The date of filing of the Articles of Incorporation was February 2, 2004.

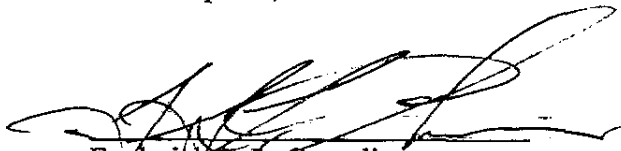
THIRD: The dissolution of this Corporation was authorized on March 31, 2004.
