OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, here by adopts the following Articles of Incorporation:

Article I  
Name

Article II  
Duration

Capital Stock

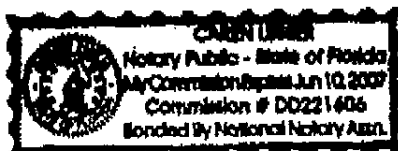




